We arranged the 1st round table with the newly elected members of the parliament in cooperation with the Human rights committee of Verkhovna Rada of Ukraine.

Milosz Hodun from the Polish liberal party Nowoczesna joined the round table in Ukrainian parliament and spoke about the Polish case of “free LGBT zones” and the negative consequences of launching such zones for the Polish government.

Fulcrum UA has become a member of LGBTI Liberals of Europe and now we represent their network in Ukraine. We also joined the Alliance of Liberals and Democrats for Europe (ALDE) Annual conference and had meetings with the EU Parliament MPs.

We conducted a research on political views of LGBT people and allies, and disseminated this information among political parties. In addition to this, we developed a guide for political parties «How to engage LGBT people?”

After a group for traditional values was created in the Ukrainian parliament, Tymur Levchuk published a blog criticizing the initiative that was published by FOCUS magazine. The publication reached 100 thousand readers of the magazine.

Introduction of the term “civil partnership” into Ukrainian legal field with the definition, which is inclusive towards LGBT+, with the expansion of the “list of relatives” through the anti-corruption agenda.

A draft law N. 4294 from 30/10/2020 with amendments to the Law “On preventing corruption” which expands the list of relatives. Initiator of the draft law – MP Oleksiy Zhmerenetsky.

Due to the absence of the institute of civil partnerships in the legal field of Ukraine, the members of Ukrainian parliament can hide their assets using their civil partners – this point is described in the official notes to the draft law.

Establishment of the institute of civil partnerships for LGBT+ military – through fraternization.

A draft law with amendments to several laws on defense of the rights of brothers and sisters in arms N. 5595 from 1/06/2021. Initiator of the draft law – MP Oleksiy Zhmerenetsky.

.results

The draft law regulates: right to health, access to palliative care, obligation to provide medical information to a partner, access to autopsy and related information, legal formalities by notary.

Engagement of All-Ukrainian Council of Churches and Religious Organizations to support religious institute of fraternization, which at the same time will be inclusive towards LGBT+.

Introduction of the term “civil partnership” into Ukrainian legal field with the definition, which is inclusive towards LGBT+, through the economic agenda.

A draft law with amendments to the Law “On the state social standards and social guarantees” in relation to the households.

According to current legislation, when one wants to receive a subsidy - whole family budget is taken into account. Due to the absence of the institute of civil partnerships, LGBT+ couples can have privileges bypassing the law, as they do not have access to legal formalization of their relationships.

We conducted a sociological research (with 3 focus groups) on the situation of LGBT military people in the Ukrainian army, including transgender soldiers, veterans and volunteers.

Tabor Production studio launched 4 high-quality short videos about LGBT military coming outs: Nick Buderatsky, Yaryna Chornohuz, Nastya Konfederat (Manzhola), Sebastian Romanov. Videos have gathered more than 78 000 views on YouTube and 8 000 views on Facebook.

Queer Film Festival Sunny Bunny and Docudays Film Festival included the videos in their programmes.

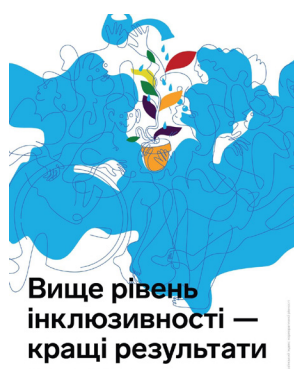

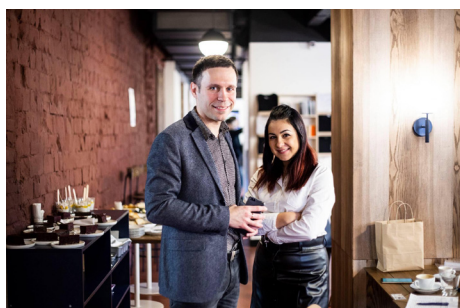

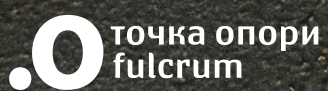
